## Orff Schulwerk Certification Program for Music Specialists

This special program for music educators, music therapists, choral directors, and classroom teachers with extensive music background is offered to those who wish to learn the fundamental pedagogy of Carl Orff's music and movement for children. The approach is one of active music-making through singing, instrumental ensemble on special instruments, movement, and improvisation. The curriculum is based on the sequence outlined by the American Orff Schulwerk Association (AOSA). Special topics in the course include multicultural applications of the material such as folk dance sessions and story telling.

### Orff Schulwerk Certification Level I

No previous Orff Schulwerk training is required. This is a complete certification program based on the Level I course guidelines published by AOSA. Course content includes study of the pentatonic scales, body movement, improvisation, and the soprano recorder. Assignments are given in practical orchestrations for children using bordun and ostinato.
